3 MS. BOWMAN: While we're waiting for him, perhaps  
4 we could proceed on number 32 --

5 MR. HARVIE: That's agreeable.

6 MS. BOWMAN: -- which is Kematch.

7 MR. HARVIE: I'm also on that matter.

8 MS. BOWMAN: In this case, the agency is seeking  
9 a three month temporary order. In court with me today is  
10 the social worker, Carrie-Lynn Greeley (phonetic) --

11 THE CLERK: I'm sorry --

12 MS. BOWMAN: -- mother --

13 THE CLERK: -- can I get the name of the worker  
14 again?

15 MS. BOWMAN: Carrie-Lynn Greeley.

16 THE CLERK: Thank you.

17 MS. BOWMAN: Mother and father entered their  
18 consent on May 3rd. Mr. Gilson is involved for West Region  
19 and he's indicated that West Region will not be taking a  
20 position. So at this point in time I'd ask the worker to  
21 present the plan.

22 MS. GREELEY: The plan is a three month temporary  
23 order for Phoenix Sinclair. Over the period of the three  
24 months, there's a couple of expectations on both parents,  
25 Samantha Kematch and Steven Sinclair. Both parents are  
26 expected to participate in an appropriate parenting  
27 program. With regards to Samantha Kematch, she's expected  
28 to participate in a psychiatric or psychological  
29 assessment, to be arranged with her and the agency. And  
30 both parents are expected to attend regular weekly visits  
31 with their daughter at the agency office.

32 THE COURT: Are there other children?

33 MS. GREELEY: No, not with our agency.

34 THE COURT: Okay. Are there other children?

1 MS. GREELEY: Yes, there's a son.

2 THE COURT: And where is the son?

3 MS. GREELEY: I believe he's with Cree Nation  
4 Child and Family Services.

5 MR. HARVIE: I can confirm that.

6 THE COURT: Thank you.

7 MR. HARVIE: On behalf of Anishinaabe Child and  
8 Family Services, Your Honour, we take no position in this  
9 matter.

10 THE COURT: Thank you.
