My name is Kimberik Ann Edwards and we have met once before outside your office back in June (HONDED in Petition For Family Service Minister To Do her Job or Resign (June 12)) I AM writing you the plea to take yet another closer look at the policing + JUSTICE in this matter the TRAVISTY THAT HAS BECOME OF Phoenix Death + Investigation as well as keep on you records the Sullen Racism I have endured Fighting For A Treaty Native Child And her Grieving Father NELSON DRAPER STEVE SINCLAIR TREATY # 275-01336-01 BY THE NATIVE AUTHORITIES, as well as THE ASSEMBLY OF MB CHIEFS AND ITS GRAND CHIEF Ron EVANS

I AM enclosing Letter of Authorization of Release for you to keep in your records, and please note that after 9 months of fighting with THE AMC THAT THE ONLY REASON that we have obtained A Lawyer is THAT ELDERS FROM the Four Authorities want to make Steve talk instead of her primary care giver in her life (MYSELF) AS WELL BACKED BY THE AMC WANT TO FORCE UIM FOR "SAKE OF COMMUNITY HEALING" make Funeral Arrangements Together with (SAMANTHA KEMATCH) THE ACCUSED.

I AM ALL THAT I SAY I AM SURE her whole SINCLAIR FAMILY will testify to this UNDER OATH AS WELL AS her Uncle (MICKY KEMATCH) THE ACCUSED, BROTHER who had Phoenix in his home living with him + his wife (CRYSTAL HILL) FOR 6 MONTHS in 2004 AND WAS ACTIVELY Looking For her all THROUGH 2005 + 2006 UNTIL THE DISCOVER in MARCH.

We are all well aware that your office has no obligation to get involved in the RCMP / Crown investigation or trial, however we implore Sir to meet with us to take on record what we know (JUST THE FACT) AS NO ONE FROM RCMP OR CROWN'S OFFICE AWARE OF all these people have not spoken to ANY OF THEM (FOR THE RECORD)

In the event that a meeting can not be arrange I AM enclosing a complete TIME LINE OF her LIFE with us, AS IN AS THE the BLATANT DISRESPECTFUL Run Around that we have gotten FROM ABORIGINAL LEADERS, we have no where to go SIR IN MB + THE Federal Government can not help us AT this TIME.

We have had to endure being LEFT OUT OF ALL healing Ceremonies Pow wows AND have had to deal with the TASK OF knowing ABOUT + trying TO PUT Mock Funeral TO STOP, Being PLANNED with the help OF ELDER + CHIEFS SAMANTHA KEMATCH it was said to have been TAKING PLACE (Dec 15, 2006)

In close MR Premier I AM CONFIDENT THAT IF YOU INVESTIGATE THESE matter (BEHIND THE SCENES IF NEED BE) YOU WILL FIND MY STATEMENT AND CLAIMS TO BE ACCURATE AND TRUE, FOR I HAVE NOTHING TO GAIN BY LYING AND NOTHING TO LOSE IN FIGHTING FOR MY LITTLE girl Phoenix She had NO NO'S in LIFE with us, AND JUSTICE MUST SERVE ON THE SIDE OF THIS INNOCENT, INHUMANLY TREATED CHILD.

Phoenix Sinclair's LIFE

Spent in THE CARE OF KIM EDWARDS

Summer of '98 - MET Steve Sinclair & we became friends. MUCH OLDER THEN him. I TRIED TO Be there to help him. In LIFE he was a kid of 18. As well as Mickey Kematch

April 2000 - Phoenix Victoria Sinclair is Born To Parents Nelson Draper Sinclair TREATY STATUS #275-01336-01 AND Samantha Kematch - Taken Away BY CFS AT BIRTH

July 2000 - Phoenix is Returned To Samantha Kematch AND Steve Sinclair, Residing together on Magnus Ave.

August 2000 - I MET Phoenix, began taking her on occasion then on the weekends to give her parents A BIT OF A BREAK

Sept 2000 - Samantha Kematch becomes Pregnant (AND MOODY) & I've Begins to BRING Phoenix AROUND my home (1331 Selkirk) more often and expresses concern about Samantha's coldness AND Distant Behavior To their daughter

OCTOBER 2000 - Phoenix Begins to spend more + more Time In my home until I would have her on THE weekdays + she would go home For weekend visits (sometimes staying longer) BUT ALWAYS come BACK TO MY home.

MAY OF 2001 - [REDACTED] is Born, AND Phoenix Goes home to meet Sister AND Be together AS FAMILY.

June 2001 - Samantha Kematch abandons whole Family Steve Phoenix and I who are old [REDACTED] - Steve is over whelmed and washes his brand of his relationship gets it together for his girls the Best a nineteen year old can, with a Year old + infant - she asks me to help by taking Phoenix to live with me just for awhile.

July 2001 - [REDACTED] passes away in Steve arms, he's taken into Police station and kept there until a Popsy declares her death of natural cause (SOS) Steve is devastated, Sam is found by police and they bury their daughter, we needed 2 different viewings because of Family Contention, the day of funeral police presence is requested Samantha is taken to + from Cemetary by police. And at request of family Phoenix goes home to be with her daddy.

ALL THIS TIME FROM JULY TO JULY CFS DOES NOT VISIT, home a lot once went back to check on Phoenix. No community support is given to Steve after death of [REDACTED] Steve falls into Great depression and begins to drink heavy, his older sister becomes concerned and tells me, Steve agrees the best place for her to be is in my home, wife from charms way and CFS if complaint is made.

August 2001 - July 2002 - Phoenix is living with me, Samantha in all this time visits Phoenix a total of 3 times at 1331 Selkirk, Last visit was ~~the~~

Asked to leave because she was calling Phoenix (BITCH LITTLE BABY) NOT WANTING to go to her, she didn't (Phoenix) know her and did NOT go to strangers, AND even though she was her mother she was A stranger TO Phoenix.

Steve needed the C.T.B and supplied Phoenix needs Diapers formula toys, all or most clothes were donated to her by my friends, I believe she also received social assistance as she lived in MB/Regional housing.

July 2002 - Phoenix Goes home for extended visit as I have to go away for couple weeks - when I returned Steve told me she was apprehended by CFS (our Feds) I call northwest child and family services to tell them her father wants her in my home, they say they need to confirm they do and STAN WILLIAMS comes out to my home to do paper work and within 3 days criminal id abuse reg. is checked & cleared and she is placed back in my home.

STAN WILLIAMS COULD TELL you when they pulled up in front of my house & Phoenix saw me you could hear her screech with delight (through closed windows) AND that he had to get out of the car cuz she was out of her car seat trying to get out to me (Family could also tell you numerous times they witnessed her sheer love for me - called me her MOM "You are her mother ds for a were concerned" AND THIS ATTITUDE IS PRESENT TODAY STILL.

OCTOBER 2002 - (Inner office stuff) Paper work is done and I receive first and only cheque from Family Services

November 2002 - STAN Williams speaks to me over the phone (He had not seen her or myself since dropping her off in July) asks me my opinion as to whether her father should, or is ready to take care and control. Being completely honest I said "NO" (and Steve knows this) have brief conversation on work - (see TIMELINE) and we hang up

3 DAYS LATER

STAN Williams phones me and tells me Phoenix is cleared to go home and I since knowing the family he doesn't have to be there THAT I SHOULD just take Phoenix to Steve. And I do so (knowing she would just return to me at his request)

THAT is EXACTLY what happen

December 2002 - Phoenix time is spent between my home (her home) STEVE and his older sisters over holiday

January 2003 - Phoenix is back living at my house (1331 Selkirk) Full time

All this time "NO" visit by social worker!

February 2004 - Samatha comes to visit Phoenix asks to take Phoenix for extended visit. I tell her she must ask Steve. She leaves without seeing Phoenix (Doesn't even ask how she is) I talk to Steve over the phone immediately and he says NO and I agree

Because she wanted to take her across the country in a Big Rig with her Boyfriend (Karl Wesley McKay) and SOMETHING is TOLD 'ABSOLUTELY' NOT AND WHY SHE LEAVES AND DOES NOT RETURN FOR 2 MONTHS - SAM (RUMORED TO BE WORKING AT CLUB REGENT) getting her life together

April 2003 - Sam returns asks to take Phoenix for short visit to the park, Downtown DO PARKS, Phoenix out of Diapers (BX 2Ys) Traveled ~~light~~ Light AND NO BAG (NO SNACK, NO TOYS NO BLANKIE (NEEDED) NO CLOTHS) THIS IS THE LAST TIME I PERSONALLY SAW PHOENIX.

- MX EXHUSBAND RETURNED TO OUR HOME TO LOOK AFTER OUR CHILDREN AGES 16, 14, 12 I MOVED OUT, HOWEVER CONTINUED TO RECEIVE CTB - GIVING HIM MOST OF MONEY ~~AS~~ ~~WAS~~ RECEIVING NO WELFARE (NO) SORRY INCORRECT, ALSO RECEIVED WELFARE AS I JUST NEEDED TIME AWAY (PERSONAL) SPACE CALLED CFS + SADIX TOLD STUBS CALL.

• DECIDED ON NO RECONCILIATION - SEPERATED SINCE 98/99  
 MK 2003 - ROHAN STEVENSON APPLIES FOR CTB FOR OUR CHILDREN, (THIS MK PAPER TRAIL PROOF) WELFARE IS CONTACTED AND I AM CALLED INTO OFFICE, AND TOLD I WOULD BE INVESTIGATED, ACCUSING ME OF HAVING MY EXHUSBAND LIVING WITH ME (ADMITTEDX OUR SPLIT WAS GOOD AND HE WAS ALWAYS AROUND FOR HIS CHILDREN - WE DID WHAT GOOD PARENTS DO IN A SPLIT (SUCKED IT UP FOR THE CHILDREN) I WAS TOLD BY THIS WORKER I WAS LOOKING AT 75 GRAND SINCE 98/ AND I REPLIED NO DAMN WAY (I HAD PROOF) AND THEN TOLD THEM HOW INCOMPENT THEY WERE BECAUSE YES SOMEONE HAD BEEN LIVING WITH ME I GUESS ILLIGOLIX

AND THAT SOMEONE WAS PHOENIX SINCLAIR AND SAID THERE'S YOUR WELFARE FRAUD, BOTH ME FOR HAVING HER SHARING THE FOOD, LIGHTS WATER + GAS WITH HER AND EITHER STEVE OR SAMANTHA (STILL NOT SURE WHO RECEIVED WELFARE I SUPPOSE STEVE cuz he receive CTB) SHE LOOKED AT ME STUNNED (I GUESS Bk MZ HONEST) WELL! I DONT KNOW WHAT TO DO WHAT WOULD YOU SUGGEST BE DONE I REPLIED "CLOSE MZ FILE" I DONT WANT WELFARE HOWEVER I SURE NEEDED IT LIVING PRACTICALLY ON THE STREET STAYIN' AT FRIENDS AND LEFT

JULY/AUGUST 2003 - WELFARE INVESTIGATORS CONTACTED ME THROUGH RAHAN AS I HAD NO ACTIVE PHONE AT TIME I CALLED THEM + COOPERATED WITH THEIR INVESTIGATION UNTIL MZ EX SISTER-IN LAW (ATTORNEY MANAK BETH STEPHENSON) AT THAT POINT ALL CONTACT STOPPED, AND I WAS TOLD I WOULD OWE WELFARE I BELIEVE \$4000 OR SOMETHING LIKE THAT AND COULD NOT OPEN NEW FILE (ALL THIS CONFIRMED THROUGH INCOME TAX RECORDS)

SEPT 2004 - RAHAN STEPHENSON LANDS IN HOSPITAL IN GRAVE CONDITION MZ 17 YEAR OLD DAUGHTER PARKS IN THE PARKING LOT BEHIND MARY LAND HOTEL, GETS OUT OF THE CAR AND SEES PHOENIX THROUGH A WINDOW WAVING TO HER EXCITEDLY ALL OF A SUDDEN SOM COMES FLYING OUT THE DOOR YELLING AT HER (FRANKIE EDWARDS WILL TESTIFY) HOW DID YOU GET THIS ADDRESS? WHY ARE YOU HERE? FRANKIE'S GRANDMOTHER + FRANKIE TELL HER JUST PARKED THERE TO GO TO HSC

LAST TIME FRANKIE SAW HER MZS ADDRESS ON MCGEE WHERE CFS WAS CALLED + LEFT HER FOR THE RECORD - ON THE RECORD

PLACE BETWEEN SINCLAIR SISTERS + SAM NO CONTACT  
HOWEVER IS MADE WITH PHOENIX (SISTERS WILL TESTIFY  
IF ASKED LIKE I SAID BEFORE TOLD OH SHE'S HERE  
OR OH SHE'S WITH WESLEY'S FAMILY (FEB 2006)
